REGISTRATION

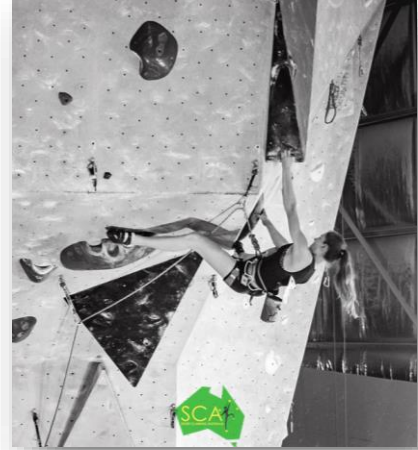
